## REDUCING OFFICE SUPPLY EXPENDITURES

As a necessary cost savings measure, this memo is to remind departments that they must purchase only approved, low-cost items when ordering office supplies.

On March 2, 2009, this Office notified departments of the need to reduce costs by buying less expensive office supplies. For example, by ordering lower cost ballpoint pens rather than more costly pens, we estimated annual savings of \$162,000 countywide. To ensure that departments captured these savings, on March 16, 2009, the Internal Services Department (ISD) issued a purchasing bulletin to departments to standardize office supplies purchases on listed low cost items.

A review of more recent office supply purchases indicates the need for greater departmental attention to purchasing low cost office products. To provide additional direction to departments, the attached "Office Supply Listing" provides an updated listing of common approved office supplies. When departments purchase any of the listed categories of supplies, they should purchase the listed items or those of equivalent low cost. Otherwise, departments must document and retain the reasons for buying items outside this list.

ISD is in the process of reducing the 18,000 products currently available through our office supplies contract to develop a low cost countywide office supplies formulary. This formulary will be in a catalog format and loaded onto the eCAPS procurement module within the next 45-days for departmental access. Until such time as the full catalog is available, to reduce expenditures in this area, each department should use the attached listing of substitute items.
